

## 20th ANNIVERSARY SWEEPSTAKES

**No Purchase Necessary to Enter to Win. A purchase will not increase your chances of winning.**

The Virginia College Savings Plan<sup>SM</sup> (Virginia529<sup>SM</sup>), an independent state agency of the Commonwealth of Virginia with its principal office located at 9001 Arboretum Parkway, North Chesterfield, Virginia 23236, is sponsoring a giveaway of one (1) eight (8) semester Virginia529 prePAID<sup>SM</sup> (prePAID<sup>SM</sup>) contract (Sweepstakes). Virginia529 is an Internal Revenue Code Section 529 qualified tuition program. A Section 529 college savings account is an individual savings account intended specifically for the payment of qualified higher education expenses for a designated beneficiary. Customers are encouraged to obtain all enrollment materials, including the Program Descriptions, by calling 1-888-567-0540 or by downloading them from Virginia529.com and to read them carefully before investing. For residents of states other than Virginia: your state or the beneficiary's state of residence (if different) may sponsor a 529 plan that offers state income tax or other benefits not available to you through Virginia529.

### **Prize:**

One (1) randomly selected winner will win one (1) eight (8) semester Tier I prePAID contract (Prize). The value of the Prize is between approximately \$62,600 and \$70,000, depending on the final prePAID contract pricing for 2016-2017 and the age of the winner's named beneficiary.

### **SWEEPSTAKES TERMS & CONDITIONS**

By entering and participating in the Sweepstakes, each entrant fully and unconditionally agrees to and accepts the following Sweepstakes Terms & Conditions which are final and binding in all matters related to the Sweepstakes:

### **Eligibility:**

1. Must be a U.S. citizen or legal U.S. resident of one of the fifty (50) United States or the District of Columbia at time of entry to enter, excluding New York and Florida. Residents of New York and Florida are not eligible to participate in the Sweepstakes.
2. Must meet all requirements for purchasing and owning a prePAID contract or a Virginia529 inVEST<sup>SM</sup> account at the time the Prize is awarded.
3. Employees of Virginia529 as well as their agents, successors and assignees, and individuals engaged in the development, production or distribution of Sweepstakes materials, their advertising and promotion agencies and any and all other persons associated with the Sweepstakes and each of their immediate family members (spouse; parents, siblings, children, grandchildren and their spouses; and in-laws) and members of the same household (whether or not related) are not eligible to participate in the Sweepstakes or be named a beneficiary of a Prize.
4. Winning the Prize is contingent on fulfilling all requirements set forth in these Sweepstakes Terms & Conditions.

## **Timing & How to Enter:**

1. The Sweepstakes begins September 23, 2016 at 12:00 a.m. ET and ends on November 8, 2016 at 11:59 p.m. ET (Sweepstakes Period). During the Sweepstakes Period there are two (2) ways to enter: (1) Online: Visit <http://www.Virginia529.com/20years/sweepstakes> during the Sweepstakes Period, complete the online entry form, and submit it to receive one (1) entry into the Sweepstakes; and (2) Onsite: Visit the Virginia529 booth at an event that Virginia529 participates in during the Sweepstakes Period during times when the Virginia529 booth is open, complete a designated official entry slip, and submit it at the Virginia529 booth to receive one (1) entry into the Sweepstakes or use the designated computer at the Virginia529 booth to submit an entry (as determined by Virginia529 and made available at each event). Virginia529's computer and staff are the official timekeepers for the Sweepstakes. **One entry per person regardless of method of entry.**

Virginia529 will use its best efforts to notify the winner by phone or email on or about November 10, 2016. Prize winner has three (3) business days to reply or contact Virginia529 to claim the Prize or the Prize is forfeited.

If, in Virginia529's sole discretion, a winner is found to be ineligible to open a Virginia529 account or is not in compliance with these Sweepstakes Terms & Conditions or cannot be found after reasonable efforts are made, a winner will be disqualified and an alternate winner may be selected by Virginia529 in its sole discretion. In no event will Virginia529 be responsible or liable for any damages or losses of any kind should a winner be found ineligible.
