I understand that this change of beneficiary is a non-taxable event for federal income tax purposes if the new beneficiary is a "Member of the Family," as defined in the Glossary of Terms, of the current beneficiary. I understand if the new beneficiary is a "Member of the Family" of the prior beneficiary and is in the same generation as the former beneficiary, the change is not subject to federal gift or generation-skipping transfer tax. If the new beneficiary is in a lower generation than the previous beneficiary, the transfer will be subject to federal gift tax and may be subject to generation-skipping transfer taxation even if the new beneficiary is a "Member of the Family" of the previous beneficiary. Also, I understand that my beneficiary change may be denied or limited if it causes one or more accounts administered by Virginia529 (including Invest529, Prepaid529, CollegeAmerica, and CollegeWealth accounts) for this beneficiary to exceed the \$500,000 maximum account balance limit. I certify that I have neither given nor received any payment or other consideration for the transfer of this account.
