

529 DAY SWEEPSTAKES

No Purchase Necessary to Enter to Win. A purchase will not increase your chances of winning.

Virginia College Savings PlanSM (Virginia529SM), an independent state agency of the Commonwealth of Virginia with its principal office located at 9001 Arboretum Parkway, North Chesterfield, Virginia 23236, is sponsoring a giveaway of one (1) four (4) semester Prepaid529SM contract or one (1) contribution of equivalent value to an Invest529SM account (Sweepstakes). Virginia529 is an Internal Revenue Code Section 529 qualified tuition program. A Section 529 college savings account is an individual savings account intended specifically for the payment of qualified higher education expenses for a designated beneficiary. Customers are encouraged to obtain all enrollment materials, including the Program Descriptions, by calling 1-888-567-0540 or by downloading them from Virginia529.com and to read them carefully before investing. For residents of states other than Virginia: before investing, you should consider whether your or the beneficiary's home state offers any state tax or other state benefits such as financial aid, scholarship funds, and protections from creditors that are only available for investments in that state's qualified tuition program.

Prize:

One (1) randomly selected winner will win one (1) four (4) semester Prepaid529 contract or one (1) contribution of equivalent value to an Invest529 account opened during the term of the Sweepstakes (Prize). The value of the Prize is between approximately \$35,880 and \$38,880, depending on the age of the winner's named beneficiary and the program (Prepaid529 or Invest529). Prepaid529 contracts and pricing are governed by the Prepaid529 Program Description and Master Agreement and have state residency requirements and age limits on beneficiaries. Invest529 accounts are governed by the Invest529 Program Description and have no state residency requirements and no age limits on beneficiaries. Invest529 is open year round and accounts may be opened at any time.

SWEEPSTAKES TERMS & CONDITIONS

By entering and participating in the Sweepstakes, each entrant fully and unconditionally agrees to and accepts the following Sweepstakes Terms & Conditions which are final and binding in all matters related to the Sweepstakes:

1. Must be a U.S. citizen or legal U.S. resident of one of the fifty (50) United States or the District of Columbia at time of entry to enter, excluding New York and Florida. 2. Must meet all requirements for opening and owning a Prepaid529 contract or an Invest529 account at the time the Prize is awarded.

Employees of Virginia529 as well as their agents, successors and assigns, and individuals engaged in the development, production or distribution of Sweepstakes materials, their advertising and promotion agencies and any and all other persons associated with the Sweepstakes and each of their immediate family members (spouse; parents, siblings, children, grandchildren and their spouses; and in-laws) and members of the same household (whether or not related) are not eligible to participate in the Sweepstakes or be named a beneficiary of a Prize.

During the Sweepstakes Period there are two (2) ways to enter: (1) **Open an Invest529 account online:** If you open an Invest529 account online (excluding new accounts opened as a result of investment direction changes and transfers, as defined by Virginia529) during the Sweepstakes Period AND if you establish a recurring bank debit or payroll deduction for contributions to the new Invest529 account in the amount of \$25 or more by July 1, 2019 at 11:59 PM ET, then you automatically will receive one (1) entry into the Sweepstakes for each new Invest529 account opened during the Sweepstakes Period with a unique individual account owner and beneficiary combination. Invest529 account applications must be successfully submitted online by May 31, 2019 at 11:59 PM ET to be eligible and recurring bank debits or payroll deductions must be established and have successfully activated by July 1, 2019 at 11:59 p.m.; and (2) Via Mail: handprint your full name, your email address, your daytime and evening phone numbers (including area codes), and your date of birth on a 3" x 5" card, and mail the card, with proper postage affixed to: "529 Day Sweepstakes" C/O Marketing Division, 9001 Arboretum Pkwy, North Chesterfield, VA 23236 (all mail entries must be received by May 31, 2019 to be eligible for Sweepstakes entry). Virginia529's computer and staff are the official timekeepers for the Sweepstakes. **One mailed entry per person or one entry per individual account owner and individual beneficiary combination for a new Invest529 account opened online during the Sweepstakes Period (one entry per person regardless of method of entry).**

2. Winner will be selected at random from all eligible entries on or about July 15, 2019. Virginia529 will use its best efforts to notify the winner by phone or email on or about July 17, 2019. Prize winner has three (3) business days to reply or contact Virginia529 to claim the Prize or the Prize is forfeited.

3. Submitted entries become the property of Virginia529. Odds of winning depend on number of entries received.
