

Virginia529 Smart Savers Club Terms and Conditions

The Virginia529 Smart Savers Club (the "Club") is offered to Virginia College Savings Plan ("VIRGINIA529") account owners. Please read these terms and conditions carefully before joining the Club or using this site <https://www.virginia529.com/resources/smart-savers/> ("Site") and keep a copy for your records. By accessing this Site, you agree to these terms and conditions and any operating rules and policies that may be published by VIRGINIA529, as may be amended from time to time ("Terms"). These Terms set forth the rules applicable to your participation in the Club and use of the Club benefits. These Terms may be changed at any time without notice and any such changes are effective when posted on this Site.

1. Eligibility

To participate in the Club, obtain your Smart Savers Club card in accordance with the on-screen instructions at the Site. Participation in the Club is limited to individuals who are VIRGINIA529 account owners. Limit one (1) Club card per account owner. Cards are non-transferable.
